## Message from Board Member Jed Grant, PA-C

As we celebrated Independence Day this year, I reflected on this holiday and what it means to me, our nation, and the physician assistant (PA) profession. When the founders of our great nation sent King George the Declaration of Independence 246 years ago, they didn't know exactly what would happen, and it took six years to determine the outcome of that proclamation. The PA profession started similarly—a good idea from a doctor at Duke University and three former corpsmen/medics to an outcome that has proven over time to be a great idea—there are more than 140,000 practicing PAs across the United States delivering high-quality care in all types of medical specialties. The concept of a physician/PA team was revolutionary at the time and even today is sometimes challenged as the profession continues to mature.

I spent my last Independence Day in Baghdad with my supervising physician while on a military deployment. As a military-trained PA, my first experiences with supervising physicians were important for mentoring and shaping how to approach problems while also allowing me wide latitude and broad scope. Military PAs often work many miles away from their supervising physicians and must be able to make timely critical decisions independently. They knew that I needed to be able to function autonomously, with guidance when needed, and trained me to think independently to accomplish the mission. Most importantly, I had to know what I did not know—when to evacuate a patient or ask for help. Later in the Emergency Department, those same principles served me well with my various supervising physicians, who taught me little

The Board also has no authority over a medical provider's attitude, bedside manner, demeanor, office staff, prices charged, or refund disputes with a medical provider unless there is a double payment by the insurance company. The Board cannot assist consumers in obtaining medical care or financial compensation for medical malpractice.

things every day but gave me great latitude in the care of my patients. When correctly applied, the physician/PA team is very effective: The physician is there when needed for consultation but allows the PA to work efficiently without undue restrictions. I have learned so much from my collaboration with supervising physicians, and now that I am older, often working with less experienced physicians, that

collaboration often goes both ways. A strong physician/PA team makes this profession successful and good for patients. So sometimes you travel hundreds of miles to hang out with your doc on the Fourth of July to share a piece of cake and a non-alcoholic beer in a tent in a foreign land—because the relationship is that important.

# Pocket License Change as of July

As of July 1, PAB no longer issues plastic pocket licenses upon initial licensure or renewal. The Board approved this proposal at its May 9 meeting to reduce its environmental footprint and to provide immediate access to real-time and accurate license information by verifying a license online. Licensees will continue to receive a printout of a pocket license to carry with them if they choose. However, PAB strongly encourages the use of electronic services to verify a licensee's status and/or any enforcement action taken on a license.

The Department of Consumer Affairs (DCA) License Search database is updated in real-time as a license is renewed, or any time the status is changed. An easy access "License Search" button is available on the home page of the PAB website (www. pab.ca.gov) by clicking on "Verify a License." Consumers, employers, or any interested parties can verify the license status online at any time. License status can change any time during a two-year licensing period. The status can change from active to inactive, inactive to active, or retired, and licensees can be disciplined, which could have an immediate effect on their license status. If PAB staff updates the status of a license in the BreEZe system, it is reflected immediately online, and the pocket license becomes invalid. For these reasons, the online license verification system has become the optimal license verification source for consumer protection.

# Do We Have Your Email Address?

Licensees are required to provide PAB with an email address if the licensee has one. Email is an efficient channel for sharing information between PAB and its applicants and licensees. PAB will be able to communicate the status of applications, renewals, and requests for various PAB services; provide law and regulation updates; and disseminate important PAB news directly to each applicant and licensee. PAB hopes this accelerated delivery and

exchange of information will decrease processing times in all aspects of the PAB's programs and facilitate licensees keeping apprised of laws and regulations, and PAB activities. You can submit/update your email address using BreEZe or submit your physical address change with BreEZe. You may also submit your email address in writing to the PAB office—please include your name and license number.

# **Become a Board Member**

Board members collectively provide oversight and direction. Board members make important decisions on agency policies and on disciplinary actions against professionals who violate state consumer protection laws. Board members approve regulations and help guide licensing, enforcement, public education, and consumer protection activities. Some board members are licensed professionals themselves, while many others are public members. Governor Gavin Newsom appoints many board members, but the Legislature makes appointments as well. # **Controlled Substances Education Course**

Senate Bill 697 (Chapter 707, Statutes of 2018) became effective in 2020 and made numerous changes to the Physician Assistant Practice Act, which provides for licensure and regulation of physician assistants by PAB.

One of the changes impacted Business and Professions Code section 3502.1(e)(3) that states a PA who holds an active license, who is authorized through a practice agreement to furnish Schedule II controlled substances, and who is registered with the U.S. Drug Enforcement Administration (DEA), and who has not successfully completed a one-time course in compliance with Title 16, sections 1399.610 and 1399.612 of the California Code of Regulations, as those provisions read in 2019, shall complete, as part of their continuing education requirement, a course that covers Schedule II controlled substances, and the risks of addiction associated with their use, based on the standards developed by PAB.

This one change has generated many questions, and in hopes of eliminating misinterpretation of the law and to clarify how the above-referenced change impacts you as a licensee, please review the answers to the most frequently asked questions:

- Q: Do I have to complete the controlled substance education course prior to registering with DEA to obtain my DEA license?
- A: No. The controlled substance education course is a license renewal requirement and doesn't impact your ability to register with DEA if you have not completed the course.
- **Q:** Do I have to complete the controlled substance education course if I am not registered with DEA and/or authorized through a practice agreement to furnish Schedule II controlled substances?
- A: No. If at the time of renewal, you are not authorized through a practice agreement to prescribe Schedule II controlled substances and/or hold an active DEA license, you are not required to complete the controlled substance education course
- **Q:** Does a continuing medical education (CME) specific to opioids or the MAT Waiver fulfill the controlled substance education course requirement?
- A: No. While many opioid CME courses do qualify for CAT 1 CMEs, they do not meet many of the requirements of section 1399.610 of Title 16, California Code of Regulations. The MAT Waiver is required to obtain a DEA waiver to prescribe buprenorphine for the treatment of opioid use disorder and does not fulfill the requirements of section 1399.610 of Title 16, California Code of Regulations.
- Q: What is the date that the controlled substance education course was first offered?
- A: It was first offered in 2008.
- Q: What if I don't remember taking the controlled substance education course?
- A: Licensees were not required to file a copy of their controlled substance course certificate with PAB prior to 2020; therefore, the Board may not have a copy of the certificate on file to confirm whether you have completed the course. Please check with the approved providers to see if they have a record of you completing the course and can provide you with a certificate of completion. - Q: Can I renew my license if I am unable to complete the course prior to the expiration date of my license?
- A: Yes. You must complete the course prior to the expiration date of your next renewal and may furnish or order Schedule II or III controlled substances in accordance with the practice agreement or a patient-specific order approved by the treating or supervising physician.
- Q: How do I know if PAB has a copy of my certificate of completion on file?
- **A:** Visit the DCA License Search web page (<a href="https://search.dca.ca.gov">https://search.dca.ca.gov</a>) to view your licensing details. The controlled substance education course certificate of completion will show as a "Qualification" if the certificate is on file with PAB.

# **Administrative Actions–Citations**

A Citation and Fine is an administrative action by which PAB may address relatively minor violations of the Physician Assistant Practice Act that would not necessarily warrant discipline. Citation and Fines are NOT disciplinary actions but are matters of public record. Citations remain on a licensee's file for five years and are then purged. By law, payment of a fine is considered satisfactory resolution of all violations contained in the citation.
