The Physician Assistant Board's jurisdiction includes physician assistants.

The Board's jurisdiction does not include physicians (M.D.s), licensed midwives, polysomnographic trainees, technicians and technologists, and research psychoanalysts and student research psychoanalysts, chiropractors, dentists, health maintenance organizations, hospitals, insurance companies, malpractice actions/civil lawsuits, Medi-Cal, Medicare, nurses (R.N., N.P., FNP), optometrists, or osteopathic physicians (DOs).

The Board also has no authority over a medical provider's attitude, bedside manner, demeanor, office staff, prices charged, or refund disputes with a medical provider unless there is a double payment by the insurance company. The Board cannot assist consumers in obtaining medical care or financial compensation for medical malpractice.

What to Expect from a Controlled Substances Education Course Audit

The Physician Assistant Practice Act provides for licensure and regulation of physician assistants by the Physician Assistant Board. In 2020, Senate Bill 697 (Chapter 707, Statutes of 2018) made numerous changes to the Act.

One of the changes impacted Business and Professions Code section 3502.1(e)(3), which states a physician assistant (P.A.) who holds an active license and is authorized through a practice agreement to furnish Schedule II controlled substances must complete a course that covers Schedule II controlled substance and the risks of addiction associated with their use based on the standards developed by the Board.

Please review the following frequently asked questions to assist with interpreting the statutory change and to clarify how the change impacts licensees:

1. Do I have to complete the controlled substance education course if I am not registered with the Drug Enforcement Agency (DEA) and/or authorized through a practice agreement to furnish Schedule II controlled substances?

No. Only licensees who at the time of renewal are authorized through a practice agreement to prescribe Schedule II controlled substances and hold an active DEA license, are required to complete the controlled substance education course. Licensees with a license status of inactive are not required to complete the controlled substance education course.

2. What if I don't remember taking the controlled substance education course?

Prior to January 1, 2020, licensees were not required to file a copy of their controlled substance course certificate with the Board; therefore, the Board may not have a certificate of completion on file to confirm if you have completed the course. Please check with the vendors listed below to see if they have a record of you completing the course and can provide you with a certificate of completion.

3. Can I renew my license if I am unable to complete the course prior to the expiration date of my license?

Yes. Until this requirement is met, section 3501.1(d)(2) of the Business and Professions Code requires a patient-specific order approved by the treating or supervising physician and surgeon to furnish Schedule II controlled substances. A certificate meeting the requirement of California Code of Regulations sections 1399.610 and 1399.612 must be submitted to the Board before the expiration date of your next renewal cycle or you will be ineligible to renew your license. If a course is not available prior to the expiration of the next renewal cycle, please provide the Board evidence indicating your intent to enroll in a future course.

4. How do I know if the Board has a copy of my certificate of completion on file?

Visit <u>DCA License Search</u> to view your licensing details. The controlled substance education course certificate of completion will show as a "Qualification" if the certificate is on file with the Board.

5. Do I have to complete the controlled substance education course prior to registering with the U.S. Drug Enforcement Administration (DEA) to obtain my DEA license?

No. The controlled substance education course is a license renewal requirement and does not impact your ability to register with the DEA.

6. Does a continuing medical education (CME) course specific to opioids or the MAT waiver fulfill the controlled substance education course requirement?

No. While many opioid CME courses do qualify for CAT 1 CMEs, they do not meet the requirements of CCR section 1399.610. The MAT waiver is required to obtain a waiver from the DEA to prescribe buprenorphine for the treatment of opioid use disorder and does not fulfill the requirements of CCR section 1399.610.

7. When was the controlled substance education course first offered?

The controlled substance education course was first offered in 2008.

8. How do I submit a copy of my certificate to the Board?

Submit a copy of the certificate to the Board by emailing paboard@dca.ca.gov.



CURES Fee Decrease—The Controlled Substance Utilization Review and Evaluation System (CURES) fee will decrease from \$11 to \$9 annually for licenses expiring on and after July 1, 2023. The fee is assessed at the time of license renewal on licensees that prescribe, order, administer, or furnish Schedule II, Schedule III, Schedule IV, or Schedule V controlled substances. Most licensees will see an \$18 CURES fee due to the biennial renewal cycle. The fee covers the reasonable regulatory costs of the Department of Justice for operating and maintaining CURES, a critical element

in the state's effort to address the growing danger of opioid addiction stemming from prescription drug abuse. For more information about CURES, visit https://oag.ca.gov/cures.

Professional Title Change

The Board is aware there is a movement to change the title of our profession from physician assistant to physician associate. While the Board is aware of this proposed title change, it is inappropriate for P.A.s to call themselves "physician associates" unless and until legislative and regulatory changes are made to incorporate the new title.

Become a Board Member

Board members collectively provide oversight and direction. Board members make important decisions on agency policies and on disciplinary actions against professionals who violate state consumer protection laws. Board members approve regulations and help guide licensing, enforcement, public education, and consumer protection activities. Some board members are licensed professionals themselves, while others are public members. The governor appoints many board members, but the Legislature makes appointments as well. Do We Have Your Email Address?

Licensees are encouraged to provide PAB with an email address if the licensee has one. Email is an efficient channel for sharing information between PAB and its applicants and licensees. PAB will be able to communicate the status of applications, renewals, and requests for various PAB services; provide law and regulation updates; and disseminate important PAB news directly to each applicant and licensee. PAB hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of the PAB's programs and facilitate licensees keeping apprised of laws and regulations, and PAB activities. You can submit/update your email address using BreEZe or submit your physical address change with BreEZe.

You may also submit your email address in writing to the PAB office—please include your name and license number.

Pocket Licenses Are Now Printable from BreEZe!



The Board will no longer issue pocket licenses upon initial licensure or renewal. Licensees can now print their own pocket license from their online **BreEZe** account. Licensees can log into their BreEZe account, and under the "Manage Your License Information" section, they can click on the drop-down menu and have the option to print the configured pocket license. You then select the license and it will pop up in a PDF on a separate tab.

Additionally, the California Department of Consumer Affairs **License Search** tool is available to verify a license in real-time or anytime the status is changed. Consumers, employers, or any interested party can verify the license status online 24 hours a day, seven days a week.

New Temporary Licensure

Effective July 1, 2023, **AB 107 (Salas, Chapter 693, Statutes of 2021)** requires boards and bureaus to grant temporary licensure to military spouses licensed in another state in the same profession when they come to California. A temporary license is valid for 12 months, or until the full physician assistant license is issued, whichever occurs first, allowing an applicant to work on completing the application process for the full physician assistant license. Administrative Actions–Citations

A Citation and Fine is an administrative action by which the Physician Assistant Board may address relatively minor violations of the Physician Assistant Practice Act that would not necessarily warrant discipline to protect the public. Citation and fine orders are NOT disciplinary actions but are matters of public record. Citations remain on a licensee's file for five years and are then purged. By law,

payment of a fine is considered satisfactory resolution of all violations contained in the citation.
