SPONSONSORED FREE HEALTH CARE EVENTS – REQUIREMENTS FOR EXEMPTION

Title 16, California Code of Regulations Article 9 in Division 13.8 and Section 1399.620, Section 1399.621, Section 1399.622, and 1399.623

SECTION 100. CHANGE WITHOUT REGULATORY EFFECT

Pursuant to Title 1, Division 1, Chapter 1, Article 2, Section 100(b)(3), of the California Code of Regulations (CCR), the Physician Assistant Board hereby submits this written statement explaining why the repeal of Sections 1399.620, 1399.621, 1399.622 and 1399.623 and the repeal of Article 9 in Division 13.8, Title 16, CCR does not materially alter any requirement, right responsibility, condition, prescription or other regulatory element of any CCR provision.

Following is a description of the changes being made to: Article 9 ("Sponsored Free Health Care Events – Requirements for Exemption") and, Sections 1399.620, 1399.621, 1399.622 and 1399.623 in Division 13.8 of the CCR, and an explanation of why these changes have no regulatory effect:

The Physician Assistant Board is repealing Article 9, its title "Sponsored Free Health Care Events – Requirements for Exemption , and Sections 1399.620, 1399.621, 1399.622, 1399.623 and their titles in Article 9, Division 13.8, Title 16 of the California Code of Regulations (CCR) to reflect non-substantive changes to the regulations entitled, "Definitions," "Sponsoring Entity Registration and Recordkeeping Requirements," "Out-of-State Practitioner Authorization to Participate in Sponsored Event," and "Termination of Authorization and Appeal." These proposed changes do not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element of any CCR provision because the changes include repealing these regulations due to the repeal of the underlying statutory authority for the regulations and Article. Section 901 of the Business and Professions Code was repealed as of January 1, 2018. Thus, these changes are non-substantive.

The Physician Assistant Board is proposing the following non-substantive changes to Article 9, in Division 13.8 and Title 16 CCR Sections 1399.620, 1399.621, 1399.622, and 1399.623:

- 1. Repeal Article 9 and its title "Sponsored Free Health Care Events Requirements for Exemption
- 2. Repeal Section 1399.620 Definitions
- 3. Repeal Section 1399.621 Sponsoring Entity Registration and Recordkeeping Requirements
- 4. Repeal Section 1399.622 Out-of-State Practitioner Authorization to Participate in Sponsored Event
- 5. Repeal Section 1399.623 Termination of Authorization and Appeal
